## Dr. John Taylor Appointed ISU NCA-HLC Liaison

Dr. John Taylor has been assigned as the HLC staff liaison to Indiana State University. He currently serves as the Vice President with the Higher Learning Commission. ### Chairs Meet on Special Emphasis

On April 23, all department chairs were invited to participate in a meeting regarding the special emphasis. The specific focus on the meeting was to have chairs provide input regarding implementation of the special emphasis, especially as it relates to maximizing student and faculty involvement and incorporating community engagement and experiential learning in the promotion and tenure process. The meeting was very productive with much lively discussion. The recommendations of the chairs have been forward to the NCA steering committee, special emphasis committee, and the Provost.

### Focus on the Special Emphasis: Defining Community Engagement & Experiential Learning

An issue that frequently arises in campus discussions regarding the special emphasis is the need for clear definitions of community engagement and experiential learning. The task of developing the following definitions was undertaken by the community engagement and experiential learning strategic planning committees in 2004.

#### Community Engagement Definition:

ISU has defined community engagement as: the development of collaborative partnerships between education, business, social services, and government that contribute to the academic mission of the University and directly benefit the community. Community engagement at ISU includes activities in the teaching, research, and service endeavors of faculty, students, and staff. Examples of community engagement activities include -Technical assistance and applied research to help increase understanding of a local or regional problem or test solutions for that problem. -Lectures, seminars, and other public forum that provide a neutral place to explore community issues. -Extension of learning beyond

#### Experiential Learning Definition:

Experiential learning, at its core is operationalized by engaging students in learning through sequential exposure to challenging, compelling, and enriching activities conducted in appropriate settings. It integrates development of knowledge, skills, and dispositions, and fosters application of methods of critical inquiry. It engages students in personal reflection in order to organize, interpret, and bring
