Department Mission: The mission of the department is to develop competent, caring nursing professionals and productive citizens. Our mission is accomplished through distance teaching modalities, experiential learning at the local level, research, and community and public service. Our nursing program is recognized for maintaining standards and criteria for educational quality by the Accreditation Commission for Education in Nursing, Inc. and is fully accredited by the Indiana State Board of Nursing.

The Department of BNC is comprised of Junior/Senior online transfer students, therefore freshmen benchmarks do not adequately reflect this population.

Department Persistence to Completion Goal and Retention(s):

Increase the number of LPN and RN students who are retained and complete their program of study by 1.5 times program of study.

Action Steps (with dates & person(s) responsible):

1. Development and implementation of online BNC orientation. (Spring 2017, Chairperson and Program Directors).
2. Continue to monitor and act on responses to the Opportunity for Improvement Survey (Ongoing, Department Faculty).
3. Continue to provide one on one training to all advisors on MySAM (Ongoing, Associate Dean, Chairperson, Student Advisors)
4. Improve departmental and course policies related to student testing and assessment by all nursing faculty utilizing Quality Matters Template including student resources link with direct access to BNC Student Handbook (Began Fall 2012 and ongoing, Department FAC and Chairperson).
5. Increase the utilization of learning contracts for at-risk students prior to course failure (Ongoing, Department Faculty, Chairperson).

Other Goal(s), Action Steps, and Benchmarks of focal interest to department:

Maintain post graduate licensure (NCLEX RN) first time pass rate at or above the national average per accreditation standards (NCLEX pass rates vary from quarter to quarter, yearly to yearly based on national student rates. Data for the prior year is not available until the following year).

Action Steps (with dates & person(s) responsible):

1. Continue to require/provide KAPLAN review for final semester seniors, pending funding from Executive Director of Nursing (Ongoing, Chairperson and LPN to BSN Program Director).
2. Continue to offer NCLEX Success Bundle from Elsevier Company as required textbooks (Ongoing, NURS 490 Course Lead).
3. Continue to transition to Kaplan products to ensure utilization of a quality product that is user-friendly and affordable for both faculty and students (Fall 2016 and Ongoing, Chairperson, and Program Directors).
4. Offer telephone calls, emails, or other “check-ins” to encourage at-risk students (as identified by standardized testing record) to continue study/review/prep for the NCLEX exam after graduating (Ongoing, NURS 490 Faculty).
5. Improve remediation efforts and early identification of and support for at-risk students. Identify any unit exam of less than 80% in NURS 338, NURS 324, NURS 424, and NURS 444 (Fall 2016, All Clinical Course Faculty and Chairperson).
