  - i. Action Item: Continued mandatory faculty training on student advisement techniques and working with MySam (J.Nelson, RN Faculty Advisors).
- c. Goal 3: Increase LPN to BSN application pool from average of 75-100 qualified applications to 130-150 to increase number of qualified applications for 50 slots each academic semester.
  - i. Action Item: Continue to work with ORR, admissions and PRB student advisor to streamline process for transcript evaluation, transfer credit work being keyed (ORR, Admissions, Dpt Chair).
  - ii. Action Item: Add additional Kaplan Admission Testing (KAT) dates to allow for additional time slots for this admission requirement (adequate re-takes). (Testing Coordinator).
- 2. Department goals to enhance student performance and/or learning outcome achievement<sup>2</sup> (include action steps, dates, and person(s) responsible for each goal):
  - a. Goal 1: Full integration of Kaplan products within curriculum and final NURS 490 Licensure Preparation Course to continue preparation and support of NCLEX preparation of curriculum and final graduate outcomes of LPN to BSN students.
    - i. Action Item: Continue to monitor ATI to Kaplan transition, with full transition planned for Fall 2018. (Jessica Nelson, Testing Coordinator).
    - ii. Action Item: Meet with Kaplan Educator to continue to coordinate integration efforts and NURS 490 alignment with full use of Kaplan products. (BNC Faculty).
  - b. Goal 2: Maintain IN Board of Nursing and nursing accreditation (ACEN) benchmark of 80% NCLEX RN pass rate or higher.
    - i. Action Item: Review current position description of testing center staff role to see if additional duties related to monitoring of course failures, lower integrated Kaplan scores or overall testing issues per students can be added to duties to ensure above issues are identified as early as possible. (Jessica Nelson, Lea Hall).

- **ii.** Action Item: Explore ways to engage faculty and academic advisors in their role in identifying underperforming students throughout curriculum (early) to begin test remediation prior to final semester of curriculum. (BNC Assessment Committee)
- iii. Action Item: Continue to collect and monitor individual course and end of program outcomes to identify areas of concern and areas for course revision (Program Directors, Jessica Nelson).
- iv. Action Item: Explore LPN to BSN curriculum revision related to concept based techniques. School of Nursing event scheduled for spring 2018. (School of Nursing, chairpersons).

# c. Goal 3: Increase RN to BSN student enrollment or Investigate New 2<sup>nd</sup> Degree Online Track

- i. Action Item: Develop taskforce to investigate current needs of RN to BSN within local area, state and beyond. Identify areas of weaknesses, examine past student data to analyze areas for improvement/opportunities for revision. (Jessica Nelson, Betsy Frank)
- ii. Action Item: Develop taskforce to explore an online 2<sup>nd</sup> degree option or progressive degree option. Proposed curriculum, resources required, partnerships etc. (Andre Kummerow, Kathleen Huun, Robert Owegi).
