Assessment Plan

The Department of Criminology & Criminal Justice BA/BS curriculum assessment plan entails two components:

- (1) A comprehensive exit exam to measure whether students demonstrate an understanding of the major requirements overall, and from each of our eight core course areas; and
- (2) An alumni survey used to measure graduate success and preparation for the field of criminal justice, including an assessment of recommended curriculum changes submitted by graduates.

1. Exit Exam

The exit exam shall be administered during the last week of classes in CRIM 499, the Criminology Capstone Course. This course was chosen as the site for the posttest because it is the culminating course in the department's curriculum and is typically taken during the spring semester of a student's senior year.

Comparative data from the pretest and posttest will be analyzed to identify the following:

- (1) Student knowledge and understanding of Criminology & Criminal Justice overall;
- (2) Student knowledge and understanding within the specific core areas;
- (3) Departmental strengths and weaknesses, both overall and in core courses, as evidenced by assessment.

Results from this assessment will be utilized by faculty to identify courses and/or material which needs further development and reinforcement, in addition to courses and/or material that students have successfully learned and internalized. The assessment rubric for the exit exam is found on the following page.

2. Alumni Survey

An electronic survey of CCJ alumni shall be administered at least once per year.
