Enrollment

What steps did you take this year to aid ISU in overcoming enrollment challenges?

1. Made several enhancements to the admission scholarship program including the addition of Laptop scholarships for all entering students with 3.0 hsgpa and Core 40 diploma who were admitted by March 1st and an increase in both the value and number of Incentive Scholarships for out-of state students. 2. Effectively promoted the Dual admit program with Ivy Tech Community College-Wabash Valley (72 dual admits between 1/1/06 and 5/16/06) 3. Revision of work-study budget on campus to support a greater number of students 4. Established a new position in the Office of Admission of Asst. director for Volunteer Outreach in order to tap into our alumni, faculty and students resources for recruitment. 5. Authorized the Task Force on the First Year to study all programs, practices, and policies that impact the first year student and recommend changes to impact retention rates.

Action Steps

Experiential Learning: Development of CIRT Continued dialog with Faculty Senate on implementation strategies for experiential learning. Progress: The Alliance for Excellence, Experience, and Engagement (AE3) has functioned and had Faculty Senate representation. CAAC has regular AE3 updates. Assure that funding for experiential learning is used effectively. Progress: It is administered by AE3. Community Engagement: Both programs of promise funded to date feature community engagement. o The focus of the Center for Local Studies is scholarship that

details the unrecorded history and folklore of the Wabash Valley and its residents. Engagement with the community is an integral part of the Center. o The Student Affairs and Higher Education (SAHE) program, in collaboration with other offices at ISU such as the Center for Public Service and Community Engagement and community partners at Rose-Hulman Institute of Technology and Vincennes University, is developing an annual student leadership institute for undergraduates across the Midwest. SAHE also is developing articulation agreements with graduate assistantship sites at Rose-Hulman Institution of Technology, Saint Mary-of-the-Woods College, Ivy Tech Community College, and Vincennes University. Assessment

What are two ways in which you evaluated the quality or effectiveness in your area last year? What changes did you make based on those assessments?

1. The program prioritization process is evaluating quality and effectiveness. It is in progress. Primary changes at this point are a proposal from General Education Council to reduce the number of general education courses and a greater knowledge base of college governance members about programs in their colleges. 2. <u>Budget</u>

As you know, ISU is facing significant budget challenges. Finding ways to overcome these while increasing efficiency requires innovation. How are you overcoming your budget challenges this year?

The Division of Academic Affairs managed budget cuts through a comprehensive plan that focused on organizational efficiency, academic reorganization, and the faculty budget pool. Improvements in efficiency across all units within Academic Affairs identified reductions to personnel costs in excess of \$700,000 and an annual supply and expense savings of over \$200,000. By combining small academic departments, reducing low enrolled courses, and increasing faculty workload across all academic colleges the annual budget for tenure-track and temporary faculty was reduced by over \$1.5 million dollars. Though the reductions to personnel costs were made without displacing current employees, the impact on the Division will be significant. A total of ten support, five EAP, and 16 full-time faculty positions were eliminated.
