Description

The Wabash Valley Educational Alliance (WVEA) is a consortium of educational entities in the Wabash Valley and business/industry. WVEA is housed at ISU Continuing Education. The Director of Continuing Education is the convener of WVEA. Partnership for Progress is co-sponsored by WVEA and the Western Indiana Workforce Investment Board. In 2005-2006, two conferences brought together leaders from business, government, and education to address economic development issues important to the Western Indiana/Eastern Illinois region. These conferences are made possible by a CAPE grant from the State.
